To qualify, the leadership position must have been voluntary. (Positions directly connected to an applicant's job, such as leading a facility Infection Prevention Committee, don't count.)

Leadership position must be directly connected to infection prevention and control and/or healthcare epidemiology.

Position could be at the local, state, regional or national level. Examples include an APIC chapter Board of Directors or serving as committee Chair, Vice Chair, or other officer. (Note that serving on a committee alone doesn't qualify. Applicant must have held a titled leadership position.)
